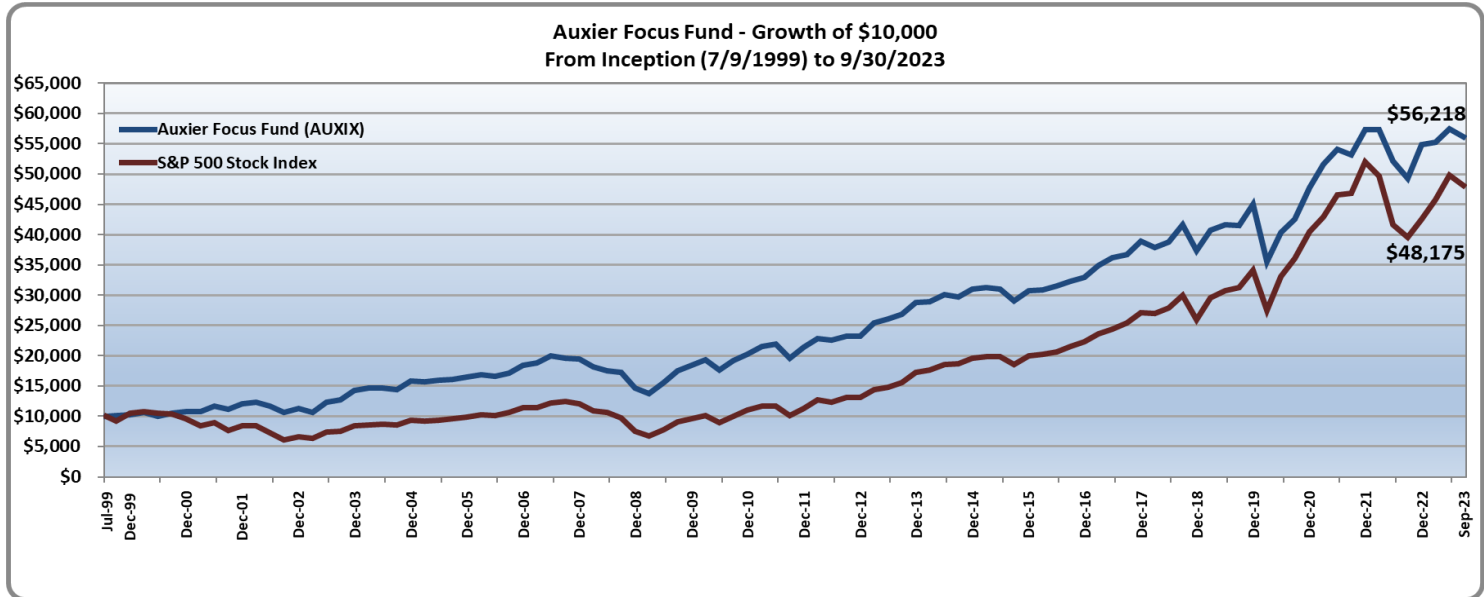


**AUXIER FOCUS FUND INSTITUTIONAL CLASS SHARES

The graph shows the value of a hypothetical initial investment of \$10,000 in the Fund and the S&P 500 Index on July 9, 1999 (inception of the Fund) and held through September 30, 2023. Fund returns (i) assume the reinvestment of all dividends and capital gain distributions and (ii) would have been lower during the period if certain fees and expenses had not been waived. Performance shown is for the Fund's Institutional Class shares; returns for other share classes will vary. Performance for periods prior to the Institutional class inception of 5/9/2012 reflects returns of the Investor Share Class. Performance for Investor Class shares for periods prior to December 10, 2004 reflects performance of the applicable share class of Auxier Focus Fund, a series of Unified Series Trust (the "Predecessor Fund"). Prior to January 3, 2003, the Predecessor Fund was a series of Ameriprime Funds. The performance of the Fund's Investor Class shares for the period prior to December 10, 2004 reflects the expenses of the Predecessor Fund. The S&P 500 Index is a broad-based, unmanaged measurement of changes in stock market conditions based on 500 widely held common stocks. One cannot invest directly in an index.
